Form 760C, Line 3 is asking for your 2018 Income tax Liability. It is possible that this question generated because you had an amount due on your Virginia tax return, as it is calculating an underpayment. Line 3 is asking for the amount on line 19 from your 2018 Virginia Form No 760.

### 760c line 3, how do I find out what to fill it in with?

For your convenience, Tax-Brackets.org provides printable copies of 136 current personal income tax forms from the Virginia Department of Taxation. The current tax year is 2019, with tax returns due in April 2020. Most states will release updated tax forms between January and April.
